

Villeneuve-Sur-Lot

Provisional Result based on Telephone Verifications

This report does not show any VELOCITIES, just Clocking Time and Flying Time. This is because the Race Point the pigeons were liberated from was changed at the 11th hour, leaving the BICC in the unenviable position of not having exact flying distances for its members from the new Race Point. The order in which the arrivals are listed is INDICATIVE (i.e. they should not be relied upon), based on the original flying distances from Villeneuve-sur-Lot (5096). As soon as NEW distances are obtained, velocities and exact positions (Open and Section) will be updated.
